



## **2016 Tidewater Home Funding Education Scholarship Program**

Tidewater Home Funding, LLC is pleased to offer an educational scholarship to one (1) Hampton Roads student.

Students wishing to apply for a scholarship:

1. Must be:
  - a. no older than nineteen (19) years of age at time of application
  - b. residing and attending high school within the Hampton Roads community
  - c. a child of a parent(s) NOT employed within the residential mortgage industry
2. Tidewater Home Funding is offering one (1) education scholarship of \$1,000.00 to a graduating high school senior (or equivalent) that has been accepted to and will attend an accredited college, university, or trade school after graduation.
3. All applicants are required to have a minimum grade point average of 3.0 on a 4.0 scale or equivalent as of March 1, 2016. Transcripts must be submitted with the completed application.
4. Must submit a written essay of no less than 950 words and no more than 1000 words on "How a college education will better prepare me for home ownership, and why home ownership is important to the community." All applications and essays become property of Tidewater Home Funding, LLC.
5. Scholarship winners will be chosen from all qualified applications based on:
  - a. Scholastic achievement, honors and awards (30%)
  - b. School activities (20%)
  - c. Hours devoted to work or volunteer service (20%)
  - d. The required essay (30%)
6. Selected applicants must be enrolled for at least twelve (12) credit hours per semester, quarter, or term for the first two (2) consecutive semesters, quarters, or terms following receipt of scholarship. Failure to maintain the credit hour minimum will result in a pro-rated repayment of the scholarship to Tidewater Home Funding, LLC.
7. Recipients of any scholarship award will be required to sign a marketing release.
8. Tidewater Home Funding, LLC employees, directors, and supervisory committee members or family members of those individuals are ineligible.

**All applications must be either received or postmarked no later than April 30<sup>th</sup>, 2016.**  
**Applications will not be accepted after the deadline date.**

Students will be responsible for providing Tidewater Home Funding, LLC with all the appropriate documentation with the application. Selected applicants will be notified by May 16, 2016. Scholarship money will be made payable jointly to the selected applicants and the educational institution.
